Re.: CE regulation No. 1907/2006 (REACH)

Co. LA/ES S.R.L. is aware of content of Regulation 1907/2006/CE (REACH) and of consequent steps for relevant implementation by manufacturers and importers of a chemical substances.

In compliance with the above mentioned regulation, Co. LA/ES S.R.L. has already issued for its acetate sheets for the eyewear industry the new format of Safety Data Sheets, as per REACH terms. Such documents will be automatically sent to customers upon their first supply of relevant product. As far the Safety Data Sheets released before Reach coming into force, complying Safety Data Sheets will be sent upon customers' request only.

In compliance with the above regulation concerning exemption for polymers and quantity limits as per Art. 6, we point you out that Co. LA/ES S.R.L. is not bound to pre-register the additives it is using in its production process.

Besides, we inform you that on the basis of our suppliers' statements, any of the substances listed in the latest Press Releases dtd. **13.01.2021** issued by ECHA are not present, in the raw materials, additives, masterbatches and charges as commonly used in the formulation of the above mentioned products compounds. Company LA/ES S.R.L. does not use any of the substances mentioned in its production processes, nor such substances can develop in our production process.

Please note that Company LA/ES S.R.L. does not carry out specific analysis in order to ascertain the presence of the above indicated substances neither in the raw materials, additives, masterbatches and charges used for its production of the a.m. components, nor in the end product and that Co. LA/ES S.R.L. has applied for and is gathering registration declarations and Safety Data Sheets of its suppliers of materials employed for the production of its Acetate sheets.

Present declaration, issued on your request and for law permitted uses, does not have compulsory significance and does not entail that our company will be liable for any false declaration given by its suppliers. Besides, as our company has no control over further use or process on goods supplied to our customers, present declaration refers exclusively to our products in the state and conditions as supplied by our company to our customers and it does not imply any responsibility from our side on any further employ of our material.
